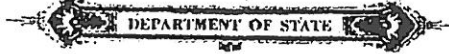

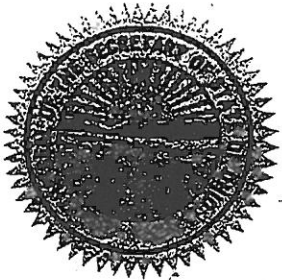

Maxine Levin, Chairman of the Board and President, and John S. Pyke, Jr., Secretary, of the Cleveland Restoration Society, Inc. (formerly the Downtown Restoration Society, Inc.), an Ohio non-profit corporation organized under the provisions of Chapter 1702 of the Ohio Revised Code with its principal office located at The Cleveland Plaza, 12th & Euclid, Cleveland, Ohio, do hereby certify that a meeting of the members of said corporation entitled to vote on the proposal to amend the Articles of Incorporation thereof, as contained in the following resolutions, was duly called and held on the first day of October, 1975, at which meeting a quorum was present in person or by proxy, and that by the affirmative vote of all the members present and entitled to vote on such proposal the following resolutions were adopted to amend the Articles of Incorporation:

RESOLVED, That the name of this corporation be changed to "Cleveland Restoration Society, Inc.";

FURTHER RESOLVED, That the Articles of Incorporation and By-laws of this corporation be and they hereby are amended to change its name from "Downtown Restoration Society, Inc." to "Cleveland Restoration Society, Inc."; and

FURTHER RESOLVED, That the proper officers of this corporation be and they hereby are authorized and empowered to implement the foregoing resolutions by filing a Certificate of Amendment to the Articles of Incorporation of this corporation with the Secretary of State of Ohio and to do or cause to be done all other things and acts as they may deem necessary, advisable or appropriate to carry out the purposes and intent of the foregoing resolutions.
