PROJECT ELIGIBILITY

Any AIA Cleveland member (Emeritus, Professional, Associate, and Allied Professional) in good standing are eligible to submit entries regardless of project size, budget, geographic location, or building type.

General Submission Requirements

- Entrant: The submitting firm or submitting individual **must be** the Design Firm (or Designer of Record) responsible for the overall design of the project concept
- Office location: The submitting firm or submitting individual identified within the criterion listed above must have an operating office (project-only or job offices are **not** eligible) in which at least one principal (“submitting architect”) in the firm is an AIA Cleveland member (Emeritus, Professional, Associate, and Allied Professional)
- Team: The submitting architect must provide an AIA membership number at time of entry submission
- Timing: A **built** project must have been **completed** anytime between January 31, 2017 and January 31, 2022.
An **unbuilt** project must have been **published** anytime between January 31, 2017 and January 31, 2022.

Projects that have won awards in other programs, including those sponsored by other AIA components, are eligible for submission in this one. Qualifying individuals and firms are encouraged to re-enter projects submitted to any earlier AIA Cleveland Design Awards or AIA Cleveland-Cleveland Restoration Society Celebration of Preservation Design Awards cycle so long as the entry did not win an award in any one of them. **AIA Cleveland Design Award-winning projects and AIA Cleveland-Cleveland Restoration Society Celebration of Preservation Design Award-winning projects from earlier cycles will not be considered in this one.**

DECLARATIONS

The entrant must declare (on the provided **AIA Cleveland-Cleveland Restoration Society Awards Declarations page**) conformance with the Intern Declaration and the Code of Ethics and Professional Conduct.

AWARDS

An AIA Cleveland-Cleveland Restoration Society Award may be given as an Honor Award, a Merit Award, or an Honorable Mention at the discretion of the jury, which is made up of AIA Cleveland Historic Resources Committee members or delegates advised by Cleveland Restoration Society jury members. Winners will be notified in advance of the virtual May 2022 Celebration of Preservation Ceremony.
